

ENEFIT HIGH-SPEED INTERNET LOTTERY CAMPAIGN TERMS AND CONDITIONS 2022

1. The organizer of the Lottery Campaign is Eesti Energia Aktsiaselts, registry code 10421629, registered office Lelle 22, 11318 Tallinn (hereinafter referred to as "Campaign Organizer"); tel. 777 4040, e-mail teenindus@energia.ee.
2. The Lottery Campaign runs from 24 Nov 2022 until 31 Dec 2022.
3. The place of conduct for the Lottery Campaign is the Republic of Estonia.
4. The procedure for conducting the Lottery Campaign is established by the Campaign Organizer in these rules. All decisions made by the Campaign Organizer during the Lottery Campaign are final and binding on all participants.
5. The value of the prize of the Lottery Campaign is up to €229.
6. As part of the Lottery Campaign, one free Enefit high-speed internet connection will be drawn between one in ten of those connecting. The premise for awarding the prize is that the winner has connected to Enefit high-speed internet in the period 24.11.2022 - 31.12.2022 and it is possible to offer a connection to the winner's address. The Campaign Organizer will reimburse the connection fee of the person who has connected and won the prize during the mentioned period.
7. All private individuals who sign an Enefit high-speed internet connection contract between 24.11.2022 and 31.12.2022 under the following connection conditions will participate in the prize draw mentioned in Point 6: The connection fee is either €199 or €229.
8. Employees of the Campaign Organizer cannot participate in the Lottery Campaign.
9. The winners will be drawn by the Campaign Organizer among all participants by using a random generator (random.org application) on 3 Jan 2023.
10. The winner of the Lottery Campaign will be contacted personally.
11. If the winner cannot be contacted within ten days after the draw, the Campaign Organizer shall have the right to draw the prize to the next person.
12. The value of the prize shall not be paid out in cash nor exchanged for some other item or service.
13. The Campaign Organizer takes responsibility for the payment of all statutory taxes related to the issuance of the prize.
14. The Campaign Organizer reserves the right to cancel the Lottery Campaign by notifying the participants immediately on the Campaign Organizer's website.
15. By accepting the prize, the winner of the Lottery Campaign confirms that he/she accepts these rules.
